#### 9.0 OPEN DISCUSSION/REPORT/INFORMATION

#### 9.1 Commissioner Reports

Commissioner Poythress -(Madera Chamber) - reported once all the Jurisdictions approve the plan for Measure T, it will be on the ballot in November. SIGMA has allocations in place and will begin work on the penalties associated on over pumping. MID has begun delivery of water and will continue for 6-8 weeks. The county approved using ARPA funds for expansion of Madera Community Hospital Pharmacy.

**Commissioner Ridge -(Golden Valley Chamber)-** reported on their successful fire works sales. The chamber has four new members. They recently held a ribbon cutting for the Liberty High School Ag building. A new restaurant, 3 Animals BBQ opened in the Ranchos.

Commissioner Scott-Contreras- (Workforce Investment Corporation) reported the business services team completed 35 in person hiring events, assisted 230 local businesses with recruitment, produced 20 videos for businesses, 30 email campaigns, marketed 17 employer workshops, and 84 social media business posting during program year. They have 6,000 face book followers with a maximum post reach of 17,000. Will soon increase video content on their YouTube channel. Participating on two regional grant programs, 2GoodJobsChallenge and CERF. Other grants include youth transition and at Valley State Prison working on exit programs for prisoners. Asked to apply for dislocated workers grant. And are working on reentry services for work readiness within the local jail and probation.

Commissioner Flores- (Industry at Large)- reported business is hanging in there. Still having difficulty filling jobs, finding suppliers especially with the highest inflation in 40 years. Businesses are lowering hiring expectations to fill jobs.

Commissioner Garcia- (City of Madera)- reported on river clean up that was completed in partnership with MID, Cal Fire, and City staff. Received 28 applications for cannabis businesses. Hoping to issue permits beginning in September for 6 retail and 2 for productions/manufacturing. They continue to work on the 145/Yosemite project.

**Commissioner Young -(Coarsegold Chamber)-** reported she is the new president for the chamber. They continue with their Peddler Fairs with a big event planned for Labor Day weekend. They held a great event for Flag Day.

**Commissioner Ahmed -(City of Chowchilla)-** reported Project Sunset (Auto Zone) will have a groundbreaking on August 19<sup>th</sup>. Housing is moving forward. Weekends are busy with a Farmers Market and Movies in the park on Fridays. Saturdays they have music and science camp in the park.

Commissioner Ditton -(Bass Lake Chamber)- reported the Bass Lake Fireworks were great. The annual cleanup is tonight at 6pm. July 23<sup>rd</sup> will be comedy night at the Pines. La Casa is doing the vacation rentals in the area. The water is high at the lake and is busy with lots of boats.

9.2 Executive Director- Reported on the ICSC show in May. It was well attended compared to the December show. The SIOR event was good networking. He attended a mission in Atlanta/South Carolina. He did the South Carolina leg, where he met with 4 site selectors. Then spent 2 days in Atlanta. Attended the Sacramento Host Breakfast and the CAL Chamber Legislative committee conference. Worked with the CALED legislative action committee and were able to kill the large warehouse legislation. Has a tour with a client in Freedom Industrial Park on Friday. Working with a potential cannabis facility on a build to suit site. Thanked the commission for the 20 years of support. This will be his last meeting as he will retire before the next meeting. Commissioner Flores thanked Bobby for all of his accomplishments.

- 9.4 **Business Assistance/Office Manager-** Lois reported there are funds available for both the City of Madera Micro Program and the County Micro Program. The county and EDC will soon have another grant program with less restrictions than the other two grant programs.
